### **WHO MAY USE THIS WARRANTY?**

EXTRACTOR CORPORATION, located at 685 Martin Drive, South Elgin, IL 60177 ("we" or "us" or "our") extends this limited warranty only to the consumer ("you") who originally purchased the product either directly from us, or from one of our approved distributors. It does not extend to any subsequent owner or other transferee of the product, except where such subsequent owner or transferee is the intended original end-user of the product.

### **WHAT DOES THIS WARRANTY COVER?**

This limited warranty covers material defects in materials and workmanship of the SUITMATE product (the "**product**") for the Warranty Period and within the Warranty Territory as defined below.

### **WHAT DOES THIS WARRANTY NOT COVER?**

This limited warranty does not cover any damage due to: (a) transportation beyond the delivery by us to either you or one of our approved distributors, as applicable; (b) storage; (c) improper use; (d) failure to follow the product instructions or to perform any preventive maintenance; (e) modifications; (f) unauthorized repair; (g) normal wear and tear; or (h) external causes such as accidents, abuse, or other actions or events beyond our reasonable control.



## **WHAT IS THE PERIOD OF COVERAGE?**

This limited warranty starts on the date of shipment of the product to you (whether from us or from one of our approved distributors) and lasts for twelve (12) months (the "**Warranty Period**"). The Warranty Period is not extended if we repair or replace the product. We may change the availability of this limited warranty at our discretion, but any changes will not be retroactive.

## **WHERE DOES THIS WARRANTY APPLY?**

This limited warranty applies only to products sold or distributed in the United States (the "**Warranty Territory**").

## **WHAT ARE YOUR REMEDIES UNDER THIS WARRANTY?**

With respect to any materially defective product during the Warranty Period, we will, in our sole discretion, either repair or replace such product (or the defective part) free of charge. We will also pay for shipping and handling fees to return the repaired or replacement product to you.
